**Wendall:**

**This is a follow up to the email and letter LARM wrote you on December 21 (attached) suggesting that we designate LONM and LARM representatives to get together to work out differences between the two organizations.**

**Mr. Barry's letter of January 12 on LONM's behalf to LARM's general counsel Jerry Pigsley states: "We are aware that the purported Directors of LARM have stated that they are willing to meet with representatives of the League to discuss the renegotiation of agreements between the League and LARM. Obviously nothing of this nature can be done until LARM has a validly elected Board."**

**As the LONM Executive Board apparently prefers, LARM representatives will not try to schedule a meeting with LONM representatives.**

**If the LONM Executive Board changes its mind in the future, LARM representatives will meet with you.**
